Do I Qualify?



Here are the ways your household can qualify for our **Affordable College Program (ACP)**:

- **Socio-Economic Education Development (S.E.E.D.)** Scholarship Recipients must be a **Student** attending a Federal Program **Title 1** or Title 4 School
- **Sports Education Socio-Economic Development (S.E.E.D.)** Scholarship Recipients must be a **Prospective Student Athlete (PSA)** attending a Federal Program **Title 1** or Title 4 School
- **Household** income
- If you or your child or dependent participate in certain government assistance programs such as SNAP, Medicaid, WIC, or **other programs**
- Household **Lifeline Benefits** means that if you or anyone else in your home receive a Qualifying Benefit from any Source you would then be Automatically Eligible for our Discounted Services – **No Questions Asked!**

Note #2: Any Federal Program Eligible School can use [Federal Program Funding](#) to pay for our College Readiness Enrichment Services and "YES" that includes Enrichment Services that have a Sports/Athletics Theme. Please contact your School's Federal Program Administrator to ask about any available Funding Opportunities. If Schools can use **over 95%** of such funding to send Teachers to receive Training, then why can they **NOT** use such funding for your Growth; Enrichment and Professional Development. **Know Your Rights!** Those Funds were actually sent to help you!

Federal Assistance Programs

If You or someone in your household participate in the **Government Assistance Programs**, listed below, you are eligible for our Affordable College Program:

- Supplemental Nutrition Assistance Program (SNAP), formerly known as Food Stamps
- WIC
- Medicaid
- Special Supplemental Nutrition Program for Women, Infants, and Children (WIC)
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance (FPHA)
- Veterans Pension and Survivors Benefit
- Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools
- Received a Federal Pell Grant in the current award year

Note: You may need to show a card, letter, or official document as [proof that you participate](#) in one of these programs when you apply for the ACP.

Tribal Assistance Programs



If you live on qualifying Tribal lands, you are eligible for the ACP if your household income is at or below 200% of the Federal Poverty Guidelines, or if you (or someone in your household) participate in:

- Any of the federal assistance programs listed above
- Bureau of Indian Affairs General Assistance
- Head Start (only households meeting the income qualifying standard)
- Tribal Temporary Assistance for Needy Families (Tribal TANF)
- Food Distribution Program on Indian Reservations

Enhanced Tribal Benefit



Households who qualify for the Affordable CollegeProgram (ACP) and are located on qualifying Tribal lands can receive:

- Up to a \$75/Event Discount on your College Readiness Training Academy Participation, and
- A one-time discount of up to \$300 for any Premium Scholarship; Technical Skills or College Readiness College ID Camp (with a co-payment of \$195 or more).

Only one Training Academy Discount is allowed per [household](#). Program rules acknowledge there may be more than one eligible household residing at the same address.

Do I Qualify for the Enhanced Tribal Benefit?

Your household can receive the enhanced benefit if:

1. Your household is located on [qualifying Tribal lands](#), AND
2. Your household income is **at or below 200%** of the **Federal Poverty Guidelines** OR any member of your household:
 - Participates in any **Lifeline Program**, or
 - Participates in the Supplemental Nutrition Assistance Program (SNAP), Medicaid, Supplemental Security Income, Federal Public Housing Assistance, or Veterans and Survivors Pension Benefit, or
 - Participates in one of several **Tribal Specific Programs**:
 - Bureau of Indian Affairs General Assistance,
 - Tribal Head Start (only households meeting the relevant income qualifying standard),
 - Tribal Temporary Assistance for Needy Families (Tribal TANF), or

- Food Distribution Program on Indian Reservations,
 - Receives Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) assistance, or
 - Received a federal Pell Grant in the current award year, or
 - Received approval for benefits under the free and reduced-price school lunch program or the school breakfast program, including through the USDA Community Eligibility Provision, in the 2019-20, 2020-21, or 2021-22 school year, or
 - Meets the eligibility criteria for a participating company's existing low-income program, and that provider received FCC approval for its eligibility verification process.

Note: If you already participate in Cable Provider or Community Based College Lifeline Program, you are automatically qualified for the ACP, and you do not need to apply and prove your eligibility a second time. Talk to your **School's Federal Program Administrator** about how to receive ACP discounts and even Funding Opportunities. If you qualify for both programs, you can choose to receive the Lifeline benefit from one Non-profit or Governmental Agency and the ACP benefit from a different Non-profit or Governmental Agency.

What are Qualifying Tribal Lands?

Your School's Location helps to determine whether your address is on Tribal lands. For informational purposes, a [nationwide map](#) is available showing Tribal lands eligible for support. The ACP uses the same definition for Tribal lands as the FCC's Lifeline program (as defined in 47 CFR §54.400 (e)). Tribal lands shown on the nationwide map include:

- Any federally recognized Indian tribe's reservation, pueblo, or colony,
- Former reservations in Oklahoma,
- Alaska Native regions established pursuant to the Alaska Native Claims Settlement Act (view maps: [2010 U.S. Census American Indians and Alaska Natives Map](#) – Alaska, [State of Alaska ANCSA Boundaries Map](#)),
- Indian allotments,
- Hawaiian Home Lands (view map: [2010 U.S. Census Hawaiian Homelands](#)), and
- Any land approved as Tribal for the purposes of the Lifeline program or the ACP by the [FCC's Office of Native Affairs and Policy](#) and Wireline Competition Bureau.

Tips for Applicants

1. Remember to Email your **Tribal Qualification and Funding Request** to your **Guidance Counselor**.
2. **On the Paper Application**, check the 'Tribal Lands' box.
3. Prove your program Eligibility by having you School's Federal Program Administrator sign your ACP Request For Funding Opportunities or Request To Participate Form or BOTH.
4. We do understand that multiple households could reside at the same address. When that occurs all families residing at that location are **100%** qualified and eligible for our program
5. Having an official Address is **NOT** a requirement for participation in our ACP Program.
6. If you qualify for the ACP but your household is not on qualifying Tribal lands, you can still receive the original Tribal discount.

Qualify Through Your Child or Dependent

Any member of your household can make your household eligible if they participate in one of the programs above. For example, if your child or dependent participates in the Free and Reduced-Price School Lunch Program or is enrolled in a USDA Community Eligibility Provision school, your household qualifies for the ACP benefit.

Affordable College Program (ACP) Financial Aid Income Requirements

Students and Families are eligible for the ACP if your income is **200% or less** than the Federal Poverty Guidelines (see the table below). The guideline is based on your household size and state. The table below reflects the income limit by household size, which is 200% of the 2022 Federal Poverty Guidelines.
